given cities of the sixth class by the Kentucky Revised Statutes, and

WHEREAS: KRS 83-A 070 enables local units of government to pay a salary  
annually to it's officials; and

WHEREAS: The City of Smiths Grove recognizes the necessity of paying  
a salary for the time and effort spent by the City Commission members; and

WHEREAS: The City of Smiths Grove recognizes that through a small salary  
it has the possibility of retaining good commission members and attracting  
good commission members in the future and can give a better quality of  
government to all citizens;

NOW, THEREFORE BE IT ORDAINED BY THE CITY OF SMITHS GROVE:


Section 1. The City of Smiths Grove hereby sets an annual salary of
